DESCRIPTION

PET COKE REMOVER is a special bleach based blend, with corrosion inhibtors and wetting & surface tension reducing agents, specially formulated to successfully remove residues or stains of coal and pet coke from metal surfaces and articles.

APPLICATION & USE

PET COKE REMOVER is mainly used in cargo and storage tanks but may also be used for the removal of mineral deposits in tanks and other closed systems.

Sweep the remaining cargo deposits using brushes, scrapers, compressed air etc but do not use any water (neither sea nor fresh water) for pre-washing the surfaces.

Prepare 1-2 samples (70:30, 50:50) with PET COKE REMOVER and fresh water in order to perform small test and determine the suitable dilution.

Apply the chemical and let it react for about 10-20 minutes before rinsing. Rinse the detergent before getting dry.

Start the chemical solution application from the lower levels gradually to the upper ones.

Consider the environment conditions and make sure that the surfaces do not get dry before rinsing.

Let the applied chemical solution to react for 10-20 minutes depending on the environment conditions (Temperature - humidity).

Rinse the surfaces, using water under high pressure. To enhance the effectiveness of the product, it is recommended to use fresh water.

The final rinsing should be performed with fresh water to remove even the salt remains of the seawater might be used.

Persisting residues may require repeating above procedure or spot cleaning with undiluted product.
